Awards: Ribbons through 6th place.

Arenas: Competition in 20x40 meter indoor arena with sand/rubber footing or 20x40 meter arena outdoors on grass. Warm-up outdoors on grass.

Other: All horses and riders on grounds must be entered in the show and have properly signed releases. Braiding and formal attire are not necessary; however, riders must wear approved helmets and boots with heels when mounted. Management reserves the right to cancel, combine, and split classes. Beverages, snacks, and lunch available on grounds. **ABSOLUTELY NO DOGS ON GROUNDS – EVEN IN YOUR VEHICLE.**

Directions: I-25 to Vandehei (Exit 13). North on East Frontage Road for ½ mile to Four Mile Road. East on Four Mile ½ mile to Yellowstone (Wyo Hwy 219). North on Yellowstone 6/10 mile to East Ole Maverick. East on East Ole Maverick 6/10 mile to 1008.
