### **Treasurer's Report**

Our checking account has a balance of \$7,443.26. Expenses for the month: \$50 to RMDS and \$75 to USEF for the date change for our recognized show. The final reported loss for our August show was \$-738.81

### **2013 Recognized Show**

- Jane and Sue reported the following information: In 2006 we had 48 entries for our recognized show. The numbers have been falling steadily until we had only 28 entries for our show in 2012. It is hoped that changing the date will help with bringing our number up to where they were previously.
- Dates have been changed to June 8 & 9 with check in Friday, June 7. This date is reserved on a permanent basis now. This date is confirmed and reserved with LCCC (which is our Recognized Show's BIG selling point; the location and great accommodations.)
- We are asking Camille Griffin to be Show Secretary again. She may be moving out of state, and a different Show Secretary may be needed.

- We have secured Brian Ross as our judge. He is from Virginia and those members familiar with him are happy with this choice of judge. He has agreed not to judge any other shows in Colorado near the date of our show. This may help draw riders from Colorado to ride.
- Laurie Mactavish from Colorado is hired as our TD.
- The Omnibus entry with our new show date still needs to be completed.

### 2013 Schooling Show

- The tentative date for our Schooling Show is September 28th. This is one week after the RMDS championships and this will be held at the Ringolsby's arena and grounds. This date is dependent on obtaining a judge for this time.

### Ride-a-Test

- The tentative date for Ride-a-Test is May 18, 2013. This date is also dependent on securing a judge. Planned site for this event is Ringolsby's arena.
